Dear Parents and Carers,

For families who are new to Biggin Hill Primary school, we provide a safeguarding bulletin each month. We often cover topics such as online safety, road safety, anti-bullying and have also previously provided a reminder of our safeguarding procedures within school. This month our bulletin focusses on attendance. As a school we are expected to maintain a minimum whole school attendance of 96% - this is critical for the educational success of children in our care.


Safeguarding is our #1 priority every day.

ATTENDANCE MATTERS

Attendance each day!

We do fully understand that from time to time children may need a day off school due to illness, however, we would ask for all families to aim for 96-100% attendance for their child. From the bar graph below, you can see that being in school each day really does provide the best chance for success.


Each school day is important - the curriculum is often fast-paced and missed learning can hinder their overall development.



Being at school on time!

Being at school on time each day is very important it enables children to enter the classroom with their peers, have the same morning input as everyone else in their class and, most importantly, access the same fairness of learning as everyone else.

Early morning work is provided from 8.40am every day, this is an opportunity for children to practice basic skills. In addition to this, teaching staff go through a visual timetable of the school day just after the register has been closed. All our registers close at **9.00am** and arriving after school after this time is classed as LATE. Not only does this affect attendance, it also does not allow for children to feel organised and prepared for what to expect throughout the school day. Being on time and ready to learn, helps children to feel settled and happy in school.



What can you do to help?

- Keep appointments such as dental and medical, where possible, outside of school hours. If this is unavoidable, please try to organise for after the register has been taken in the morning or at the end of the school day. Please try to avoid appointments in the middle of the day.
- If your child is unwell and you are not sure what to do, ring our friendly office staff and they will do their very best to advise. Please note, they are not medical professionals, however are up to speed with the latest government advice regarding COVID-19 and periods of absence required for other mild illnesses.
- If you are having problems with morning routines at home and feel you need some support, please do contact <u>k.sargeant@bigginhillps.com</u> and we will work with you to work out the best way forward
- Absence must be reported each day by 9am via the school office.

We are a fully inclusive school and as part of our statutory obligations, we meet with our Educational Welfare Officer (EWO) on a weekly basis with the aim of improving whole school attendance and to tackle persistent absenteeism. Sometimes we are required to refer cases to the EWO in line with our statutory and legal obligations. We understand that children and families sometimes need support and we have lots of good ideas and strategies to support our families - no problem is too big or too small - we are happy to help.

You will find our Safeguarding Leads in orange lanyards. We are all at the gate in the morning and at least one of us is at the end of the school day.



Here at BHPS we firmly believe that children need to feel safe and happy in order to be able to learn and for that reason safeguarding is right at the top of our priority list.
